All site orders will be through the market online store for 2024.

The first market for 2024 will be on Saturday 3rd February.

The online store will open to first round invitations at 11am on Thursday 4th January 2024. If you have received an email invitation at 9am on 4th January, you are in the first round, and these have been sent to those stall holders that have been with us for more than 6 markets during 2023.

At 9am on Thursday 11th January we will send out the second group of invitations to those stall holders that have been with us for 6 or less markets during 2023.

This is important - sites are allocated on a first come order/payment basis so don't be slow in placing your order and following up with your first three months payment within 48 hours.

If you are planning to attend all markets this year you should order your sites for the entire year and as long as you keep your site fee payments **three months** in advance your order will not be cancelled.

For our inventory management can you order the same type of site in the same section that you had in 2023. Everyone wants a site with a car space but only 27% of our sites come with a car space. If you are seeking a change to either site size or site location that you had in 2023, please request this via email stalls@warrandyteriversidemarket.com.au

If you had different and various locations throughout the year please order the location you were at the last time you attended the market and if your preference is to change to another location please email stalls@warrandyteriversidemarket.com.au with that request.

Our total sites available for 2024 are limited by our new licence conditions and some current stall holders will not be offered invitations next year.

Those stall holders effected will be emailed separately.

There are 12 markets in 2024 with 2 markets in December on the 7th and 21st December. If you order a site for the 21st December market, please make sure that you will be able to attend that market as it is on the 3rd Saturday in December and only five days before Christmas Day.

A reminder also that we must have a valid Certificate of Currency for your Public Liability insurance in our files and for our food stall applicants you must hold a current Streatraders permit.

SITE FEES FOR 2024 HAVE INCREASED

The COM has held site fees the same since 2020 but unfortunately costs to operate the market continually increase. The COM has therefore reluctantly increased site fees for 2024 as follows.

- Standard 3.2m x 1.5m table site **for an umbrella only** will now be \$50
- Standard 3.2m x 3m site with **no** car space will now be \$75
- Standard 3.2m x 3m site **with** a car space will now be \$85
- Premium 3.2m x 4.5m **with** car space on bitumen will now be \$95
